Contributions, Charges and Personal Items



Dear Parents/Caregivers

Financial support by parents has always played a significant role in contributing towards providing resources that support the learning experiences of our students. The continuing partnership between schools and parents is vital to ensuring that all students receive a level of education to benefit and carry them forward.

The Beldon Primary School Board has endorsed the Contributions and Charges schedule for 2024 as per the School Education Act 1999 (WA) and Regulations (2000).

The Schedule is broken into four sections and will allow you to calculate the **maximum** costs you may incur during the 2024 school year. Where possible, we encourage you to re-use items from the previous school year to reduce costs.

The schedule is as follows:

- Contributions
- Charges Extra Cost Optional Components
- Personal Items for personal use in the educational program
- Other Services (not directly part of the educational program)

CONTRIBUTIONS

The total amount of contributions parents and caregivers of students in Kindergarten to Year 6 are requested to pay has been set at \$60.00 per student which is within the School Educational Regulations 2000. All contributions received supplement the school's expenditure in curriculum related activities.

While contributions are voluntary, your contribution is essential. The quality of our teaching and learning programs are maximised when each family pays their child's contribution and assists in supplementing funding gained from other sources.

The School Board would like to point out that the contribution per child equates to less than \$1.20 per week over the course of the year.

CHARGES – Extra Cost Optional Components

A breakdown of estimated charges for your child's participation in excursions, incursions, and activities for 2024 has been included in the schedule below. Details on charges and costs collected in the previous year has assisted in estimating the 2024 charges. Students will only incur costs when they are involved in a particular activity, and you will be asked to make payment for each activity as it occurs. Student participation is conditional on payment and permission forms being received by the school. The amounts shown represent the **maximum** charge for scheduled activities in 2024.

EFTPOS: Payments by credit card or EFTPOS can be made in person, via telephone or by completing your card details on payment envelopes and excursion notes.

CASH: All cash payments must have details clearly stated on a payment envelope.

This information is intended to ensure all parents and caregivers understand their financial commitment and endeavour to support the school by paying contributions and extra cost optional charges when requested. Contributions are charged at the commencement of the new year however payments may be spread over the school year. Charges are billed as they arise throughout the year. Reminder of Unpaid Billing Item notices will be sent out during the school year to assist parents and caregivers with outstanding payments. Payment arrangements can be set up in the event of families experiencing financial hardship.

All payments are collected from payment boxes in blocks and may be made by direct bank transfers, credit card, EFTPOS or cash. Payments are receipted daily.
